







DETAIL P.1.1.



LANDSCAPING NOTES

- L1. SURFACE IMPROVEMENTS AND RESTRIPING WILL OCCUR WITHIN THIS LOT HOWEVER, PARKING STALL NUMBERS HAVE NOT INCREASED.
- ALL PLANTING BEDS WILL BE INSTALLED WITH 3/4" LANDSCAPE ROCK, COMMERCIAL GRADE LANDSCAPE EDGONG/CKCEPT NEXT TO CONCRETE), AND LANDSCAPE FABRIC MANUFACTURED SPECIFICALLY FOR PLANTING BED UNDERLYMBENT, UNIESS OTHERWISE NOTED ON THE PLANTING PLAN.
- L5. DAMAGE THAT OCCURS TO PLANTS DURING TRANSPORTATION AND INSTALLATION WILL BE THE RESPONSIBILITY OF THE CONTRACTOR.

- L8. SOLITARY TREES DO NOT NEED TO BE EDGED AROUND, HOWEVER ORGANIC WOOD MULCH SHALL BE PLACED AROUND THE TREE IN A MUTTLE RING THAT CONFORMS TO THE DETAIL PROVIDED FOR TREE PLANTINGS.
- L9. TREES PLANTED IN DESIGNATED ROCK MULCH PLANTING BEDS SHOULD NOT BE INSTALLED WITH WOOD MULCH.

TOPSOIL - SOD

SOD MATERIAL AND INSTALLATION SHALL CONFORM TO THE REQUIREMENTS OF SECTION 1203 OF THE CITY OF BISMARCK CONSTRUCTION SPECIFICATIONS.

IRRIGATION

CONTRACTOR SHALL INSTALL SDR 35 PVC SEWER PIPE IRRIGATION SLEEVES AS SHOWN.

CONTRACTOR SHALL PROVIDE AND INSTALL ADDITIONAL IRRIGATION EQUIPMENT TO ADD A MINIMUM OF 2 ZONES OF SPRAYHEADS AND 1 DRIP ZONE TO THE EXISTING SYSTEM.

THE EXISTING SYSTEM CONSISTS OF A BOOSTER PUMP LOCATED ON THE LOWER LEVEL OF THE EDUCATION WING AND A 12 ZONE MECHANICAL CONTROLLER LOCATED ON THE NORTH EXTERIOR WALL OF THE WING. ALL 12 EXISTING ZONES ARE BEING UTILIZED. THE BOOSTER PUMP FEEDS A 13 MAINLINE TO THE ZONE VALVES.

THE CONTRACTOR SHALL LOCATE AND CONNECT TO THE MAINLINE IN THE TURE AREA NORTH OF THE PARKING LOT. PRE-APPROVED EQUIPMENT SHALL BE RANBIRD 1804 SPRAY HEADS/SIZED AS NEEDED), RANBIRD FEB VALVES IN THE APPROPRIATE SIZED BOX, CLASS 180 PVC MAINLINE, 1004 POLYETHELENE LATERAL PIPING, RAINBIRD DRIP IRRIGATION TUBING AND EMITTERS AND RAINBIRD ESP SERIES CONTROLLER.
