HOUSEHOLD HAZARDOUS WASTE (effective 5/1/19)

Disposal of Household Hazardous Waste is free for Bismarck resident within City limits

**No Business/Commercial hazardous waste accepted*

NON- RESIDENT FEES:

Latex Paint (water based)	\$3.79/gal
Oil Based Paint/Stain	\$5.81/gal
Class I & II Oxidizers	\$1.77/lb
Class I Organic Peroxides	\$6.87/lb
Flammables (Corrosives, Toxics, Solvents, Aerosols)	\$1.77/lb
Unstable Reactives	Case by Case
Unknown Liquids or Solids	\$1.77/lb
Waste Reactives	\$6.87/lb

Prices subject to change without notice

- No drums or containers exceeding 5 gallons
- Keep materials in original containers with lids closed
- Line a box with a plastic trash bag and transport the waste in it.
- Keep containers upright
- No medical waste, explosives, ammunition or radioactive materials.

ELECTRONICS (effective 1/14/20)

Disposal of electronics is free for Bismarck residents within City limits

Fluorescent Lamp - 4 ft & under	\$0.60/ea
Fluorescent Lamp - 5 ft & over	\$1.00/ea
Fluorescent Lamp - compact w/ballast	\$1.00/ea
Fluorescent Lamp - u-shaped & circular	\$1.00/ea
High Intensity Discharge Lamps	\$2.00/ea
PCB Ballast	\$0.50/lb
